Display case in front was @ ~44°F. Manager adjusted temp. Please monitor to ensure below 41°F.

Develop a system to ensure proper holding for foods in display case.

Have all food containers covered when stored, ^{to prevent cross contamination} berry containers in back freezer were uncovered.
