Dear Mr. Thorman and the Watershed Forum Technical Advisory Committee (TAC):

The Sierra Valley Groundwater Management District (SVGMD) provided its full proposal for this grant opportunity on July 28, 2023. We would like to provide this supplemental information regarding the estimated start date and stakeholder support.

Under Item #16 of the proposal, we indicated the Estimated Start Date would be 01-01-2024. The SVGMD is prepared to begin the project as soon as funding is available; however, to be consistent with the proposed schedule and notice to proceed date provided with the requests for proposals (RFP), we would like to change the estimated start date to 02-01-2024.
