TRAINING & TESTING INFORMATION

CalCode requires each food facility to have a minimum of one owner or employee with a Food Safety Certificate; valid for five (5) years. Additionally, all employees involved with food preparation, storage, or service of food are required to have a California Food Handler Card, which is valid for three (3) years.
