# Goal of Discussion


- PURPOSE - Establish a policy regarding the use of the PG&E Settlement Fund
- POLICY SCOPE - This Policy would set forth the general process and parameters the County may utilize to determine the use of the PG&E Settlement Fund.
- BACKGROUND - The County received a \$7.8 million settlement revenue after attorney's fees, trailing cost hold-backs, CalOES & FEMA match.
- POLICY PROPOSAL - The Dixie Fire caused immeasurable damage to Plumas County and its

residents. To begin addressing these impacts and working to mitigate the risks of future disasters, PG&E Settlement Funds should be used for **County stability, hazard mitigation** and **recovery**. Recognizing that there are more worthy projects and uses of the PG&E Settlement Fund than there are funds available, projects that address direct impacts from the Dixie Fire, leverage outside funds and/or have a high level of urgency will be given priority.

# Confusion About County Settlement(s) \$17 million & \$7.8 million

- There were two settlements that the County was directly involved in: **one was a civil prosecution** by the District Attorneys of Plumas, Lassen, Tehama, Shasta and Butte counties for nearly \$30 million of which **\$17 million went to Plumas County**. The choice was made to pursue a civil prosecution because the maximum fine would have been only \$329,417, according to DA David Hollister in his one-year look-back published in May 2023.
- **This is separate from the settlement reached by the County of Plumas through its County**

**Counsel's office for \$7.8 million** to make whole the county's losses as they relate "public entities' civil legal damages including public and natural resource damages, staff and labor time, damages to pavement and roads, lost revenue, increased expenses and destroyed structures, infrastructure." This is a quote from the settlement announcement that occurred January 17, 2023. One of the outside attorneys who handled the case will elaborate on this at a future meeting.

# Dixie Fire Criminal Case Settlement Update - As Reported by District Attorney David Hollister May 2023 - \$17 million

- **\$17 million to organizations.** "This demonstration of support was accomplished by an agreement where PG&E would make \$17 million in good-faith contributions to Plumas County organizations **as directed by the Plumas County District Attorney.**"
- These awards could not be used to offset actual damages nor could they be directed to a public governmental entity
- There is an excellent review of this award online at The Plumas News called "Dixie Fire

Criminal Case Settlement Update - 1 Year Later" on May 31, 2023

- Also negotiated was the **Direct Payments for Community Recovery - DPCR.** As of April 28, 2023, the DPCR has shown the following results:
- **153 claims** with the average days from claim to payment of 60 days.
- Total paid in DPCR Program: **\$46.6 million with the range of payments from: \$55,000-\$1.96 million**

- \$200,000 to Rotary clubs. These included: Greenville Rotary, Chester Rotary, Portola Rotary

# Estimated Breakdown of civil suit by Plumas County for damage to County property

## \$7.8 million

- **10 public entities were included in a \$24 million settlement** including Plumas, Lassen, Butte, Shasta and Tehama counties; as well as the City of Susanville, Plumas District Hospital, Chester Public Utility District, Honey Lake Valley Recreation Authority and Herlong Public Utility district.
- \$10,302,851.26 million has been received by Plumas County and now sits in the Plumas County Dixie Wildfire Settlement Fund
- ATTORNEY FEES were 18%
- OES/FEMA awards TBA
- **TOTAL AWARD** per the Settlement Statement to the County of Plumas: **\$7,799,184.84**
- We are awaiting further instruction on the OES/FEMA awards.
- To date, \$10,000 has been spent of the funds for the Feral Cat Spay/Neuter Clinic due to the proliferation of cats throughout the county due to the Dixie Fire. This occurred Oct. 14.

# Revenue Received Thus Far Beyond the Settlement

- **Property Tax Backfill** - Plumas County received **\$982,926** in backfill for property tax years 2021-22 and 2022-23. This is revenue that regularly funds County operations.
- There is no more backfill available.
- **Insurance Funds for Property Loss** - \$2.2 million which includes \$500,000 for a destroyed grader. Negotiations are ongoing with the insurance companies regarding the worth of County buildings and yards that were destroyed. We are about \$1 million a part in that discussion. It is expected to be resolved within 60 days.

- Greenville Trailers provided by CalOES and then taken over by the County - **\$204,082** is uncovered at this time which includes garbage, water testing, porta-a-potties, electricity, pumping of septic. Not included is labor and fuel for servicing these units 3x a week. This is still being calculated.
- Ongoing cost of buildings that were destroyed, i.e., water, sewer, utilities. This is still being calculated.

# Sheriffs Department Dixie Fire-Related Costs

- Rental of Substation - **\$44,344** per year plus water, sewer, utilities (not yet calculated)
- Water, sewer on burned substation


