



Notice of Adoption of Ordinance Plumas County Board of Supervisors

On December 3, 2024, the Plumas County Board of Supervisors held a public hearing on the Ordinance and adopted the Ordinance pursuant to California Government Code Sections 25123(d), 25126, and 25131.

SUMMARY OF THE PROPOSED ORDINANCE OF THE COUNTY OF PLUMAS, STATE OF CALIFORNIA

The Board of Supervisors of the County of Plumas, State of California, ORDAINS as follows:

ORDINANCE NO. 2024-1158

AN ORDINANCE OF THE COUNTY OF PLUMAS, STATE OF CALIFORNIA, AMENDING CHAPTER 9 (BECKWOURTH COMPLEX AND DIXIE FIRES RECOVERY) TO TITLE 4 (PUBLIC SAFETY) OF THE PLUMAS COUNTY CODE CONCERNING RECOVERY FROM THE BECKWOURTH COMPLEX AND DIXIE FIRES

SECTION 1. Ordinance Amendment

Title 4 Public Safety, Chapter 9 Beckwourth Complex and Dixie Fires Recovery, Article 1. Findings and Title; Article 2. Mandatory Debris and Hazard Tree Removal; Article 5. Emergency Interim Housing Outside the Beckwourth Complex and Dixie Fires Area; and Article 6. Emergency Interim Housing Inside the Beckwourth Complex and Dixie Fires Area is amended, deleted, or added as shown in Exhibit "A."

SECTION 2. California Environmental Quality Act (CEQA)

Adoption of this Ordinance is exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to California Public Resources Code Section 21080(b)(3) regarding projects to maintain, repair, restore, or replace property or facilities damaged or destroyed as a result of a declared disaster and Section 21080(b)(4) regarding actions to mitigate or prevent an emergency, and CEQA Guidelines Section 15269(a) regarding maintaining, repairing, restoring, demolishing, or replacing property or facilities damaged or destroyed as a result of a disaster stricken area in which a state of emergency has been proclaimed by the Governor pursuant to the California Emergency Services Act, commencing with Section 8550 of the California Government Code.

SECTION 3. Effective Date

This Urgency Ordinance is adopted pursuant to California Government Code Sections 25123(d), 25216, and 25131 and shall take effect immediately upon its approval by at least a four-fifths vote of the Board of Supervisors.

SECTION 4. Codification

These ordinances shall be codified as approved by the Board of Supervisors, as set forth in the adopted text, as shown in Exhibit "B."

SECTION 5. Publication

A summary of these ordinances shall be posted in a prominent location, pursuant to Section 25124(a) of the Government Code of the State of California, before the expiration of fifteen (15) days after the adoption of the ordinance, once, with the names of the supervisors voting for and against the ordinance, at the Board of Supervisors' chambers and shall remain posted thereafter for at least one (1) week.
