Anyone who depends on medications that need refrigeration or medical devices that require power, should apply and register any medical related energy needs!

Once enrolled, Vulnerable Customer Status remains on an account for 90 days. The applicant can resubmit a program application to apply for a one-year extension beyond the 90 days.
