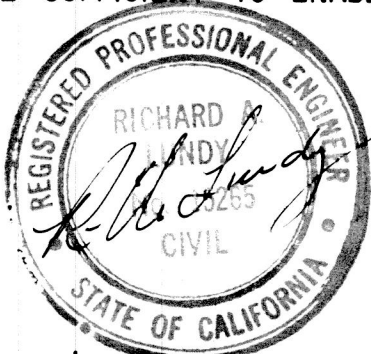


ENGINEER'S CERTIFICATE

EASEMENTS FOR INGRESS AND EGRESS OVER THOSE CERTAIN AREAS DESIGNATED LOT A, LOT B, LOT C, AND LOT D FOR USE BY ALL PUBLIC UTILITIES, LAW ENFORCEMENT AND FIRE PROTECTION AGENCIES AND THEIR VEHICLES AND PERSONNEL FOR THE SOLE PURPOSE OF PERFORMING OFFICIAL BUSINESS, AND FOR THE USE AND BENEFIT OF THE OWNERS OF LOTS 1 THROUGH 38 OF PLUMAS EUREKA ESTATES UNIT NO. 7 (PHASE I) AND OWNERS OF LOTS IN ANY SUBSEQUENT PHASE OF PLUMAS EUREKA ESTATES UNIT NO. 7.

UTILITY EASEMENTS. EASEMENTS FOR INSTALLATION, MAINTENANCE AND REPAIR OF ALL UTILITIES CONSTRUCTED OVER, ON, ACROSS AND UNDER THOSE CERTAIN AREAS DESIGNATED P.S.U.E. (PUBLIC SERVICE AND UTILITY EASEMENT) AND LOT A, LOT B, LOT C AND LOT D WITH THE RIGHT TO TRIM AND REMOVE, AS OFTEN AS NECESSARY, TREES, LIMBS AND BRUSH FOR THE SOLE PURPOSE OF INSTALLING, MAINTAINING, AND/OR REPAIRING SAID UTILITIES.

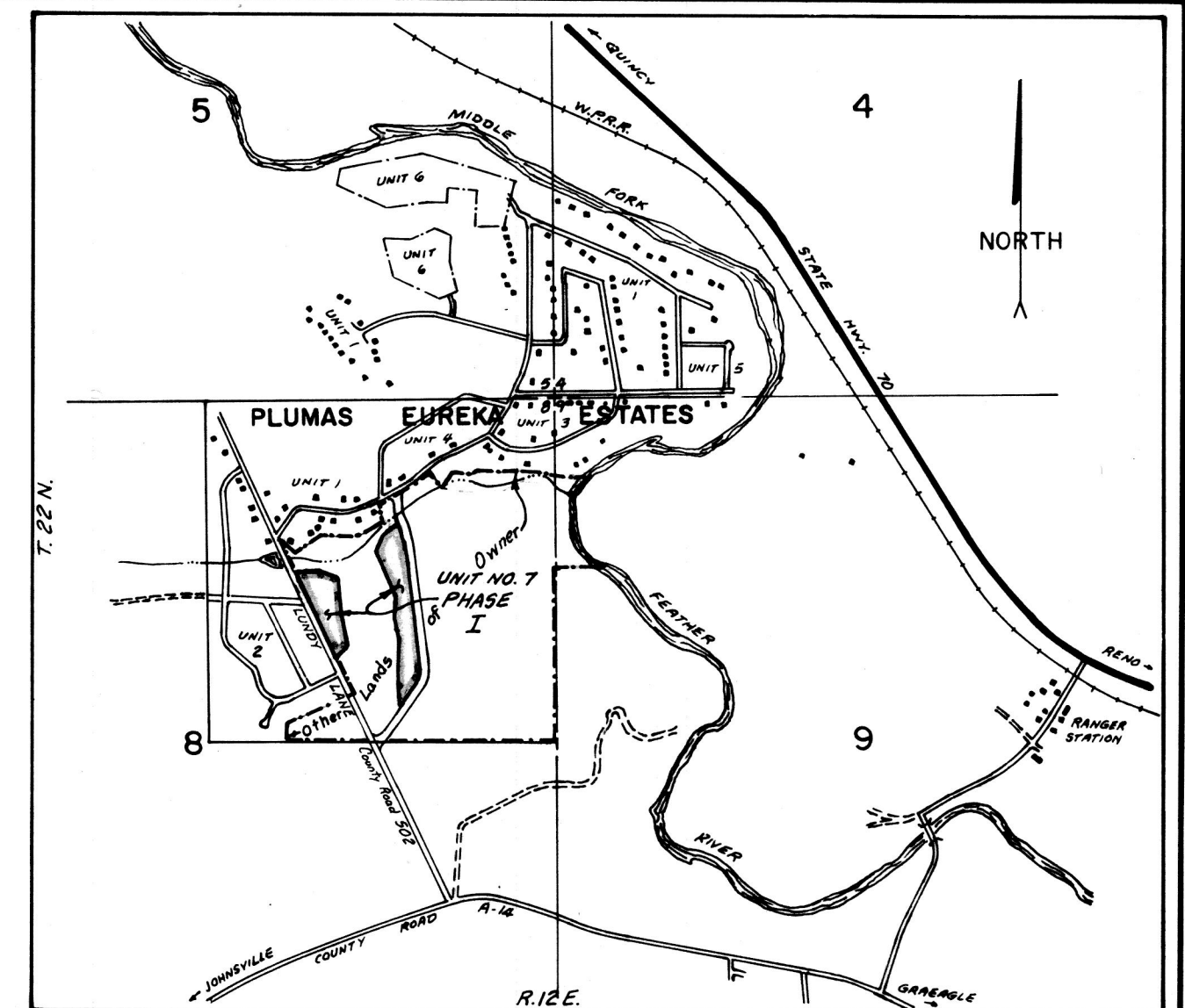
