INSTRUCTIONS TO CANDIDATE:

- Submit 1 copy of your statement in hard copy and 1 copy in electronic format i.e. email, flash drive, etc. The electronic copy **MUST** be a Word document.
- The statement must include your name, age (optional), occupation, and a brief description of not more than 250 words of your education and qualifications. All statements will be printed in paragraph format and as described in CA Elections Code Section 13307.
- Candidates shall be limited to a recitation of the candidate's own personal background and qualifications, and shall not in any way make reference to other candidates for that office or to another candidate's qualifications, character, or activities as described by CA Elections Code Section 13308.
- **Statements are printed EXACTLY as submitted.** Check carefully for errors in spelling, punctuation, and grammar before filing. These issues will not be revised or corrected by the Elections office.
- **The following formats are NOT permitted:** All Caps, Bold, Underline, OR Bullet Points.
- Fill out both sides of this form and present it with your hard copy statement of qualifications.
- If you are including endorsements from a person/committee/group/etc., you **MUST** include a letter confirming authorization of that endorsement from that source. The letter must be on official letterhead, with an original signature, and the title of the endorser clearly stated.
- If you use another person's name in your statement of qualifications, you **MUST** include a letter confirming permission to use that person's name in that way. The letter must be signed, dated, and original.
- Word count begins following: "QUALIFICATIONS:"

If an Elections Official deems a candidate statement to be in violation of the law, the Elections Official may strike any language not in compliance with the California Elections Code.
